NOTIFICATION OF SANCTION

To: Luca MARINI, Rider #10 of the MotoGP" Class

Dear Sir,

According to Article 3.5.5 of the FIM Grand Prix World Championship Regulations, we confirm our decision without a hearing.

Motive

On 23rd September 2023 at 17:05:49 during the MotoGP⁻ Sprint of the IndianOil GRAND PRIX OF INDIA at Turn 1 you were observed as being overly ambitious and causing contact with Rider #72, which severely impacted his race.

This contravenes the specific instructions given to MotoGP⁻ competitors and teams, disrupting the session, and is considered irresponsible riding causing danger to other competitors. It is therefore an infringement of Article 1.21.2 of the FIM World Championship Grand Prix Regulations.

Sanction

For the above reasons, the FIM MotoGP Stewards Panel has imposed a Long Lap Penalty. The Long Lap Penalty shall be served by the rider at the next Grand Prix race in which the rider participates * (in accordance with articles 3.2.1 and 3.3.2.3 of the FIM Grand Prix Regulations).

* The FIM MotoGP Stewards clarify that the rider's next event would be the IndianOil GRAND PRIX OF INDIA, unless the rider does not participate in this race for any reason related to this incident (as per the penalties protocol issued by the FIM MotoGP Stewards on 30.3.23).

Penalty Explanation

Following the Penalty Protocols issued to teams, this action was deemed to be an incident of Type 2: Aggressive contact with another rider at Turn 1 which severely impacted his race. As a first offence for the season, the appropriate penalty in this case is a Long Lap Penalty.

Right of Appeal

According to articles 3.4.2, 3.4.2.2 and 3.4.2.4 of the FIM Grand Prix World Championship Regulations, you have the right to appeal against this decision of the FIM MotoGP⁻ Stewards Panel to the FIM Appeal Stewards. A statement of appeal must be made within 60 minutes from the date and time of this notification, and accompanied by a security deposit of €1320. the appeal can be lodged with IRTA who may also arrange for guarantee of the security deposit payment.
