# **NOTIFICATION OF SANCTION**

To: Kaito TOBA, Rider #27 of the Moto3" Class.

#### Dear Sir,

According to Article 3.5.5 of the FIM World Championship Grand Prix Regulations, we confirm our decision with a hearing.

#### Motive

On 20<sup>th</sup> October 2023 at 13:47:06 during the Practice 2 session of the MotoGP<sup>¬</sup> GURU BY GRYFYN AUSTRALIAN MOTORCYCLE GRAND PRIX, you were observed to be riding slow online disturbing another rider at Turn 1.

This contravenes the specific instructions given to Moto3<sup>--</sup> competitors and teams, disrupting the session, and is considered irresponsible riding. It is therefore an infringement of Article 1.21.2 of the FIM World Championship Grand Prix Regulations.

## Sanction

For the above reasons, FIM MotoGP Stewards Panel has imposed a starting from the back of the grid and a Long Lap penalty for the MotoGP GURU BY GRYFYN AUSTRALIAN MOTORCYCLE GRAND PRIX Moto3 Race. (in accordance with articles 3.2.1 and 3.3.2.3)

# **Penalty Explanation**

Following the Penalty Protocols issued to teams, this action was deemed to be an incident of Type 2.b: Slow Riding on line **during last 10 minutes** of FP1, **FP2** (FP3 for Moto2/3) - disrupting another rider and possibly affecting their progression into Q2. As a **first offence** for the season, the appropriate penalty in this case is a starting from the back of the grid and Long Lap penalty.

# **Right of Appeal**

According to articles 3.4.2, 3.4.2.2 and 3.4.2.4 of the FIM World Championship Grand Prix Regulations, you have the right to appeal against this decision of the FIM MotoGP<sup>-</sup> Stewards Panel to the FIM Appeal Stewards. A statement of appeal must be made within 60 minutes from the date and time of this notification, and accompanied by a security deposit of €1320. the appeal can be lodged with IRTA who may also arrange for quarantee of the security deposit payment.
